We want to thank you and the Ventura community for your patience and understanding throughout our Soil Remediation Project at the Ventura Compressor Station. I would like to inform you that as of August 31, 2023, we completed the Soil Remediation Project.

We value the collaboration with the Ventura Unified School District that resulted in the soil remediation work to take place when school was not in session, over the summer and on weekends. Work crews have removed the contaminated soil that was associated with historical industrial uses of the site prior to SoCalGas ownership, and have replaced it with clean, imported soil. The work was performed by licensed contractors and inspectors in accordance with applicable regulations.

The safety and wellbeing of our community, customers, and employees is paramount to everything we do at SoCalGas. And we remain committed to keeping the Ventura community informed with timely, open, and transparent communications.
